It will be submitted to the Registered Charities as part of the Annual Return and shared on the website.

Non-Financial Highlights from the Performance Report

A. Learning How To

- The significant donations over 2021 from members and non-members pg 11
- Classes/Workshops kept going over 2021 pg 18+20
- 42% of the total operating time was with COVID-19 Government implemented restrictions pg 21
- Celebrating Steph Fairless who ran extensive activities using Sugarfoot Stomp as a platform 'over the hill' in Martinborough and Greytown pg 22

B. Building and Connecting the Community

Spellbound Blues was the first ever event to be run by a Sugarfoot Stomp Member- Kara
 Sage who was not connected to the Board pg 28

C. Keeping it all Running

- The Profit Share Cap Committee formed a new policy around how the profits are shared from classes and workshops. Many thanks to the members who contributed their time to participate in the meetings and discussions to arrive at an outcome that supports the Sugarfoot Stomp Charity pg 38.
- 30% of members participated in the Annual Member survey. There were 7 responses in total to the Annual Community survey. The Board would like to see a higher participation

- rate in 2022 as these surveys contain testimonies to strengthen the Performance Report and the Board's Strategy Meeting to plan for the next year pg 38.
- Areas of organisation and management. Summary of the outputs for 2021 pg 44.

Financial Information

Financial Report Presented By Treasurer Amy Burt

- Financial Accounts have been peer reviewed by Carleen Pimm on Sunday 23rd January 2022. These were done very quickly and easily as Xero was used for the first time since Sugarfoot Stomp began in 2018. Carleen commented that the accounts were all in order and easy to peer review due to the accuracy of the reconciliations by the treasurer using Xero. No questions were asked/raised from the peer reviewer about the accounts pg 52.
- Sugarfoot Stomp generated a **surplus of \$5,259.37** in 2021. This is a big contrast to the (\$4,219.12) Financial LOSS in 2020 pg 46.
- Able to transfer \$6,000 into the savings bank account -01 pg 40.
- Sugarfoot Stomp is well on the way to raising \$10,000 as a 'buffer' or 'rainy day fund'. This number will need to be *slightly higher* for 2022 and beyond due to the rise in outgoings from new insurance and music licensing costs.
- Following the treasury strategy plan clearly worked and will need to continue.
- The treasurer now has a much better understanding of what is possible when the accounts are tracked properly over a full financial year pg 56.
- The 5 year savings plan voted in the AGM for 2020/2021 is well on track to be met. Adjustments were made for the 2022 Budget and current savings goals to reflect the increase in outgoings.

Treasury Recommendations

In Summary

- To raise *more than* \$10,000 in savings in the bank to act as a 'buffer' or 'rainy day fund'. Keep adjusting to current numbers of outgoing costs.
- No online platforms for raising funds. People pay in cash or via bank account.
- Facilitator invoices to be sent to the treasurer within 2 weeks of the amount being issued to them and no longer.
- There is still money outstanding from 2021 that is to be reviewed by the Board pg 56.
- Related Party Transactions have been recorded pg 55.
- Moving forward, Sugarfoot Stomp is not out of the woods yet. All Sugarfoot Stomp members need to understand the frugality needed *and* the focus for members to generate income, with no losses, in 2022 and beyond to cover overheads and the budget plan.
- Continue to follow the current treasury strategy and processes. They are working.
- Take time to really celebrate the successes of 2021.

- Already collecting data through registration forms for classes / workshops. Will help to make decisions on what to do.
- Idea is to provide opportunities to be involved with Sugarfoot Stomp.
- Designed to be easy / manageable. The measured goals are EASY to track.
- ABCs of Sugarfoot Stomp shown through the Calendar of Outputs budget for 2022 pg 3.

- Language Change: 'Teacher' will change to Class, Workshop, or Event Facilitator. This is to be more inclusive of our community, recognise Swing Dance as a cultural dance, and to encourage the message that all members are facilitators pg 6

From AGM 2020/2021

- Discussion about how to raise funds to cover overheads, making up the loss and savings target. Amy Burt asked for a decision on which plan to follow. The 3 year, 5 year or 6 years. There is a need to be conservative with the spending and it was highlighted that more members help out with generating income. External help through grants as well.
- The members would like to review progress at the AGM in 2021/2022

Tom Eastman Motioned that the 5 year target be Sugarfoot Stomp's financial target to make back the loss, cover the overhead and meet the \$10,000 savings goal. This is raising **\$5,490.40** in 2021 with the increase of \$100 to that figure over the next 5 years until 2025.

Overview with treasury operating process pg 1

- Overheads have increased pg 2
 - Onemusic for music licencing
 - Volunteer Wellington
 - Insurance for Sugarfoot Stomp
- Total budget has gone **UP** in 2022. Numbers have doubled from 2021 pg 2+3
- Sugarfoot Stomp has FREE subscriptions for operating as a charity pg 4.
- 5 year savings target outlined. Were able to save \$6,000 in 2021. Expenses have increased. These factors are reflected in the 5 year savings target for 2022 pg 5.
- Should be able to make \$3,000 from Classes and Workshops pg 6.
- Annual Appeal raised \$800. In the Performance Report (pg 27 & 28) there were 4 members and 2 non-members that raised money. The treasurer expects MORE people to contribute to fundraising in the Annual Appeal for 2022. We can do better pg 6.
- Donations in 2021 are a factor in the final profit figures.

- In 2021 it was looking like the membership subscription amounts would have to be raised to \$100 plus. With the accurate tracking on the financials the membership subscription figures are able to be adjusted to \$45.00 for waged members and \$40.00 for unwaged members. This is a pleasing outcome and shows the importance of accurately tracking the Sugarfoot Stomp accounts pg 6.
- Grants are not an option. You can only apply for/have one grant at a time. These are mainly for Māori and Pacifica projects. Therefore the Annual Appeal is crucial for members to raise funds.
