Financial Report Presented By Treasurer Amy Burt

- The ultimate success of the 2022 finances is through following the Financial Report and Strategy. This is an example of excellent governance by the Board pg 52
- Xero is essential for the accounting and now gives comparisons between 2021 and 2022 pg 52
- The Treasurer thanks the patience of members as growing the finances takes time spanning quite a few years. The organisation is playing the long game for ultimate success. This means that all current financial processes are fully fit for purpose enabling the financial position of Sugarfoot Stomp readily ascertained at any point in time as the Board requires via the constitution pg 52
- Membership Subscriptions DO NOT cover the overheads and operational costs. Member projects are a choice and fixed income from these activities are NOT GUARANTEED at any given time throughout the year.
- Loss of Profit from 2021 from payments not followed up by facilitators were written off as irrecoverable pg 52
- Loss of Profit from 2022 from payments in Learn to Swing Dance were unable to be traced as they were cash payments pg 52
- Account Signatories changed in October.
- Account Signatories gained access to the 02 account in this change.

Treasury Recommendations

In Summary

- **All financial processes to remain the SAME** for 2023 until Sugarfoot Stomp meets its financial strategy as advised by the Treasurer.
- The finances require careful management as the Membership Subscriptions **DO NOT** cover the overhead and operations costs. There is also the factor of building the savings too on top of that.
- Follow the Budget for 2023.
- Facilitators to issue their invoices within 2 weeks to help the Treasurer with ascertaining the financial position.
- All payments TO Sugarfoot Stomp settled within the due date. It takes more time to track and chase up missing payments.
